## Credit Reporting

-  **Credit Ratings** – Ratings are posted on the 'Company Details' page of [www.jewelersboard.com](http://www.jewelersboard.com), when you select 'Advanced Search' to find a business listing. It's FREE.
-  **Credit Reports** – 25 free annually. Additional reports: \$10 U.S. members, \$15 non-U.S. members. Interchange\* participants \$5. Order credit reports online 24x7.
-  **Weekly Alert** – Free weekly e-newsletter along with a comprehensive monthly industry report, the Alert includes companies newly listed with JBT, those inquired on by members five or more times in the past week, current items of interest, rating changes, and industry businesses that have filed bankruptcy or discontinued operations.
-  **JBT Credit Watch** – Online alerts for certain credit-related information changes on companies you choose to monitor. \$100 annual subscription. Interchange\* participants free.
-  **\*Interchange** - We process 3 million trade-payment references each year from accounts receivable aging data shared confidentially by members through the Interchange program. Data is updated each month to refresh credit report content. All members are encouraged to join the Interchange and pay less for credit reports after their free 25, while receiving many other free valuable benefits. Call JBT to participate.
-  **JBT CreditShare** - Free online platform for JBT's member community to confidentially share and view an expanded set of customer payment behaviors including memo, bounced checks, returned goods and more.





## Collections Services

JBT has collected tens of millions of dollars for members, often at absolutely no cost.


-  **Past-Due Stickers** - Use these stickers, with JBT Logo, to your invoices as added clout. Free with membership.
-  **Free Demand** - JBT notifies the debtor directly, on your behalf, to encourage payment. If you notify us within the selected 10-, 20-, or 30-day period that you have been paid, there is no fee charged for the collection.
-  **Collector Action** - JBT Senior Collectors, certified by the Commercial Law League of America, work aggressively to recover your receivable(s). Fee is only 15% of amount collected.
-  **Attorney Service** - When a debtor still refuses to pay, JBT-affiliated attorneys pursue legal action. Fees set by attorney.
-  **New Claims & Bankruptcy Report** - Weekly list of all claims placed with JBT during the prior week, including debtor name and claim amount. Also listed are key developments in industry cases filed with the U.S. Bankruptcy Court. \$200 annual subscription. Free to Interchange\* participants.
